**Sub: Secret Ballot Elections III - authorities permitted to enter po
booths during voting.**

The Polling Officers and staff of the polling booths may be informed that the following authorities, other than those nominated for polling duties, shall be authorized to enter the polling booths on the days of Secret Ballot Election on production of valid proof of identification.

- i. Central Observer appointed by Chairman, SBEC.
- ii. Returning Officer and Additional Returning Officer.
- iii. Presiding Officer and Assistant Presiding Officer.
- iv. Any Flying Squad/ Special team constituted by Central Observer/ Returning Officer/ Presiding Officer.
- v. Secret Ballot Election Committee members consisting of Sh. Kishore/Chairman, Sh. Alok Kumar/Member & Sh. Rajiv Ga ED/E/RRB, Rly. Board & Member Secretary, on production of Rail Board identification proof.

2. No other authority/person should be allowed to enter the polling booths.
