Attention is invited to Board's above mentioned letter (under ref. i) wherein 'two 2nd AC Card passes' of Zonal jurisdiction i.e one each to the Divisional President and Divisional Secretary were allowed to Divisional Executive Committee of All India SC/ST Railway Employees Association.

The Ministry of Railways has now decided to extend the facility of one (1) 2nd AC Card pass in favour of Branch President/ Branch Vice President or Branch Secretary of Branch Executive Committee of All India SC/ST Railway Employees Association and available upto Divisional jurisdiction. The use of Card Pass will be after prior approval of Headquarter leave/sanctioned leave related to AISCSTREA meeting/s.

Further, in supersession of Board's letter No.88-E(SCT)I/80/2 dated 12.07.1996, it has been decided that the periodicity of Informal meeting be increased from the existing two (2) in a year to three (3) in a year with the administration, subject to request/demand received from AISCSTREA.
