Sub: Acceptance of technical resignation of IR officers for their permanent absorption in PSUs/ABs.

Ref: Railway Board's letter No. 2021/F(X)II/PW/3 dated 21.09.2021 and 03.04.2023 (copy enclosed).


Your attention is drawn to Railway Board's letters dated 21.09.2021 and 03.04.2023 referred to above vide which the authority for accepting the technical resignations of officers below the Administrative Grades of Indian Railways is delegated to the General Managers (GMs) of Zonal Railways.

2. However, it has been observed that in some cases, officers below Administrative Grade working on deputation to CPSEs/ABs have been absorbed by getting their technical resignations accepted by the concerned General Managers of Zonal Railways and without informing Railway Board.

3. It may be noted that the officers below Administrative Grade are appointed on deputation basis to CPSEs/ABs with Board's approval only. Therefore, in cases where officers (below the Administrative Grades) on deputation to PSUs/ABs are seeking permanent absorption, their technical resignation cases must first be sent to the Railway Board for review and approval. Only after receipt of approval of Railway Board, such cases should be forwarded to the respective General Managers (GMs) of Zonal Railways for acceptance of technical resignations of the officer concerned.

4. The receipt of this letter may be acknowledged and compliance may be ensured in future.


Sub: Delegation of Powers to General Managers – Revision of Annexure – II to Chapter V,

During a review of delegation of powers to General Managers, with a view to make it more effective, it was felt that the delegation of powers earlier issued needs to be updated. Accordingly, revised version of supersession the delegation of powers in the form of Advance Correction Slip No. 90 is enclosed herewith. The orientation of the attached delegation of powers is different from the one earlier issued in the following manner:

- i. The items have been updated by incorporating the amendments already issued.
- ii. The items which have lost relevance have been deleted.
- iii. The items appearing in various parts of the earlier delegation have been consolidated.
- iv. The numbering system has been streamlined, so that quoting of items in files becomes easier.
- v. Too many details and notes have been done away with.
- vi. The items, on which separate detailed instructions from Board exist, have either been omitted or only a brief reference has been given.
- vii. The items which are not covered in this delegation will be governed by existing codal provision or subject specific guidelines of Board.




