(PBC No.39/2025) and 19.02.2025 (PBC No.55/2025)

Attention is invited to Railway Board's letters under reference on the above subject, circulated in PBC No.39/2025 dated 05.02.2025 and PBC No.55/2025 dated 24.02.2025, whereby all Divisions/Units were advised the further course of action to be adopted in various cases related to grant of benefit of notional increment subject to the policy directions issued by the nodal Department viz., DoPT.

In terms of para 7 of DoP&T O.M.No.19/116/2024-Pers.Pol.(Pay)(Pt) dt 14.10.2024, circulated by Railway Board in letter dated 03.12.2024 (PBC No.39/2025), action has to be taken to allow the increment on 1st July/1st January to Railway employees who retired/are retiring a day before it became due i.e., on 30th June/31st December, and have rendered the requisite qualifying service as on the date of superannuation with satisfactory work and good conduct for calculating the pension admissible to them. As specifically mentioned in the Orders dated 06.09.2024 of the Hon'ble Supreme Court, grant of the notional increment on 1st January/1st July shall be reckoned only for the purpose of calculating the pension admissible and not for the purpose of calculation of other pensionary benefits.

It has been decided, in consultation with the Accounts Department, that while processing the cases for grant of the notional increment in all such cases, prior vetting of Associate Finance should be obtained and pay updated in IPAS also. Memorandum for revised last drawn pay (notional) on account of grant of notional increment should be issued by the respective cadre section, before taking up the process for revision of pension and issue of PPO.

This has the approval of the PFA and PCPO.
